#### UNAPPROVED MINUTES

Absent: Ray Ochromowicz. Staff in attendance: Jennifer Reyes, Stella LiPomi, Jean Gross, Judy Ruemmele, Barbara Saunders, Mary Knudson, Kelly Damron, Sean Tovey, and Erin Pool.

Recreation Specialist Sean Tovey introduced Kathy Maloney to the board. Kathy recently competed in the national Special Olympic games held in Kansas. Kathy was awarded three gold medals as a member of the bowling team. Board President Hincapie presented Kathy Maloney with a plaque recognizing her accomplishments.

### **Program Report – Jennifer Reyes**

This month I wanted to reminisce about the last fifteen years at M-NASR. I am celebrating my anniversary the day after the Annual Halloween Dance. I accepted a position back in 1995 as the Physically Impaired/Visually Impaired Recreation Specialist where I designed the programs in that area. After a couple years Suzanne Bear came aboard and I was promoted to the Staff Enrichment Manager/Support Staff Manager. I've seen staff graduate high school, college, and start families. I have really enjoyed seeing people grow as I have. During the years I have seen M-NASR flourish. I have seen a single computer go to a network, a cubicle go to a beautiful home, a few vans to a fleet, increased program service and so on. I am proud and thankful for being a part of this team. Sometimes I don't think we thank the ones above us enough. So thank you for the work you all do on a daily basis at your member districts. I really appreciate what we all do together.

One area I want to touch base on is our swimming programs at M-NASR. For over ten years M-NASR has been fortunate enough to have a cooperative with Skokie Park District and Morton Grove Park District to secure space at Niles West or Niles North on one evening during the week. This year before summer it was brought to our attention that after ten years we were going to have to look for either a different facility or different day or time to offer our weekly swimming programs. One thing we are very good at is being flexible. M-NASR was lucky enough to find a time on Saturday's from 4:15p.m. to 6:45p.m. that would accommodate our kids swim lessons and adult swimming program. While preparing for this season we had to take in consideration of the new time change that this may pose on our families, so we offered a class at the YMCA in Des Plaines for kids at our original day and time. With that being said we found that both classes are very popular. So currently we have swimming on the east side of our member districts and one on the west side. We also offer an open swim on Saturdays as part of our kid's line up in Park Ridge. This is a class for children just to have fun in the water and does not focus on swim lessons.

On September 19, 2010, I had the opportunity to attend the championship qualifying game for the Special Olympics Volleyball Team where M-NASR took the Gold. This took place in Gurnee, at Warren Township High School. The team was coached by Kelly Damron, Senior Operations Manager. As the Superintendent of Recreation I attend many programs to see our families and hear what's being said about M-NASR. As I attended the competition I found this group of individuals to be a very intimate team. As I was watching the game I spoke to families and friends of athletes on the sideline cheering the team on. I knew every participant that played that day. One participant that was playing that day had a fan/friend that decided to attend. I would like to share a story of how one of our fans got to this tournament. This individual is a

friend of one of the athletes and because he was not registered for the program he is not allowed to ride the van. But he wanted to come and support his friend. I also want you to know the friend is also a M-NASR participant who does our bowling program on Saturday's each season. I was amazed to find out that this participant took a Metra Train to Grayslake to get on his bike for 30 more minutes to peddle his bike to Gurnee. He told me it took two hours to get there. As I spoke to him he told me he had to do the same thing on the way back home. I told him he wouldn't be home until after 6:00pm he didn't care as long as he could come and watch his friend play. He was on the sideline trying to figure out how he was going to get public transportation out to Rockford to watch him play again on October 30. I looked at how positive and excited he was for his friend and this reaffirmed the importance of all that we do. What would a world be without park districts or SRA's?

The overall number of registrations for the Fall Season this year is just about the same as last year. This season we continued to see popularity in three programs that included; Friday Night Fever, Casino Trip, and Artist Studio in the Adults with Mental Disabilities area. We are taking a trip on October 10<sup>th</sup> to the Cadillac Palace to see the Lion King. I will report on that trip next month.

## Staff Update

Jessie Ritter, M-NASR Support Staff Manager, has been very busy with orientations/trainings. On September 13, 2010, she hosted a Program Leaders Training for our part-time staff. This training was very successful with around 10 part-time staff in attendance. During this training she spoke to the leaders about the importance of communication with the full-time staff, and expectations of leading a program. Also during the training she worked with the leaders and discussed how a difficult situation may or may not have been handled differently. Jessie also did some retraining on CPI holds. This training is designed to restrain a child as a last resort and safely. The true purpose of CPI is to learn to watch for signs that a child or adult is getting agitated and try to deescalate them so you don't have to restrain them. Full-time staff and program leaders are required to stay current on this training.

This year's Orientation was themed "One vs. 100" and was held on September 15, 2010. All the full-time rec. staff was required to attend. The Orientation took place at Golf-Maine Park District, Feldman Park in Niles and was great for this Orientation. Tracy Gillingham, Youth/Teen Recreation Specialist also designed a session for all the staff to experience on communication and teambuilding. As staff entered into the orientation they were given a sticker with a college on it and that's how groups were broken up for the evening by the enthusiasm in the room you could tell the staff definitely got a lot out of this training. Almost 60 staff including full-time attended.

Mary Knudson and Shannon Mikulecky continue to prepare for their session at the National Institute on Recreation Inclusion in Schaumburg as it quickly approaches us in November.
